

TRABZON METROPOLITAN MUNICIPALITY EVENT APPLICATION CLARIFICATION TEXT

This clarification text has been prepared by Trabzon Metropolitan Municipality as the data controller within the scope of Article 10 of the Law No. 6698 on the Protection of Personal Data ('KVKK') and the Communiqué on the Procedures and Principles to be followed in the Fulfilment of the Disclosure Obligation.

As Trabzon Metropolitan Municipality, we show great sensitivity to the processing and storage of all kinds of personal data belonging to you in the best possible way and with care. Pursuant to Law No. 6698 on the Protection of Personal Data, your personal data; Trabzon Metropolitan Municipality will be able to process, record, store, classify, update and disclose/transfer your personal data to third parties within the scope of the purposes described below, in accordance with the law and honesty rules, in cases permitted by the legislation and / or limited to the purpose for which they are processed. With the awareness of this responsibility, we process your personal data detailed in the Trabzon Metropolitan Municipality Personal Data Processing Policy on the website www.trabzon.bel.tr in the capacity of Data Controller within the scope of the Law No. 6698 on the Protection of Personal Data and related legislation. Within the scope of Law No. 6698 on the Protection of Personal Data and related legislation, Trabzon Metropolitan Municipality, as the Data Controller, has received personal data for the marriage school activity registrations;

- Name, surname, TR identity information, date of birth of the person concerned
- Telephone, e-mail contact information,
- Photographs and video recordings are taken from personal data.

PURPOSE OF PROCESSING YOUR PERSONAL DATA

- Carrying out communication activities,
- Promotion, announcement, publication on social media and informing the public about the sports activities carried out by our municipality,
- Carrying out organisation and event activities,
- Providing social activity activities for citizens,

METHOD AND LEGAL REASON FOR COLLECTING PERSONAL DATA

Your processed personal data is processed on the basis of the legal reasons of 'data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject' and 'explicit consent of the data subject' in Article 5 of the Personal Data Protection Law. Your personal data received is obtained and processed electronically through the website and stored in accordance with the law.

PERSONAL DATA TRANSFER

Your personal data for the above-mentioned purposes and within the framework of the conditions specified in Articles 8 and 9 of the Law:

Your personal data processed domestically;

- In the event of any legal dispute and litigation, to the lawyer of the relevant institution, authorised public institutions and organisations, relevant law enforcement officers and courts in order to resolve legal disputes or in accordance with the relevant legislation,
- It is transferred anonymously to the Ministry of Sports in order to carry out sports activity activities, to follow up sports activity processes and to make evaluations.

Your personal data processed abroad;

Our Municipality carries out such overseas transfer transactions in accordance with the provisions regulated by the KVKK.

- Photographs and videos taken in sports activities organised by our Municipality are transferred to social media accounts to overseas servers in order to promote, announce, publish on social media and inform the public about the activities carried out by our Municipality.

STORAGE AND DISPOSAL OF PERSONAL DATA

Our Municipality stores personal data in line with the purpose of processing personal data in a proportionate manner for the purpose of processing. In this context, personal data processed on the basis of your explicit consent and in line with legitimate interests will be processed for the purposes and methods specified unless and until you withdraw your explicit consent and will be stored in accordance with the Law.

YOUR RIGHTS REGARDING YOUR PERSONAL DATA

You can review the principles adopted by our Municipality in relation to the processing of your personal data in the capacity of Data Controller within the scope of the Personal Data Protection Law No. 6698 and the relevant legislation and the rights of the person concerned in accordance with Article 11 under the Personal Data Protection Law in detail from the Personal Data Processing Policy at www.trabzon.bel.tr

You can submit your requests within the scope of Article 11 titled 'Rights of the Relevant Person' of the Law on the Protection of Personal Data to Gülbaharhatun Mahallesi Kahramanmaraş Caddesi No:159 Ortahisar/Trabzon in writing by filling out the KVKK Application Form according to the 'Communiqué on the Procedures and Principles of Application to the Data Controller', to trabzonbuyuksehirbelediyesi@hs01.kep.tr via Registered Electronic Mail (KEP) by signing with 'secure electronic signature' or to kvkk@trabzon.bel.tr via e-mail.

If you submit your request to our municipality in accordance with the application procedures, we will finalise your request free of charge as soon as possible and within 30 (thirty) days at the latest, depending on its nature. However, if the transaction requires an additional cost, the fee in the tariff determined by the Personal Data Protection Board may be charged.
